INTERNATIONAL MASTER'S - DOCTORATE STUDENT ADMISSION ANNOUNCEMENT TEXT

International students who want to apply for Master's and Doctorate programs for the Master's and Doctorate programs with thesis in the Spring semester of the 2025-2026 academic year must apply to the Institute of Health Sciences in person with the following documents until the end of working hours between **December 22,2025 – January 02, 2026**

Documents Required at the Time of Application: (documents must be up to date)

1. Notarized Turkish translations of bachelor's degree diploma, master's degree diploma and transcript documents indicating his/her graduation from a four-year educational institution and the translations should be made by a sworn translator.
2. International students who have completed their education abroad are required to have their diplomas approved by the Turkish Consulates in their countries.
3. International students who completed their undergraduate and graduate education abroad should submit a school recognition certificate for programs without clinical practice, and an equivalency certificate for programs with clinical practice. Those certificates will be provided by YÖK (Turkish Higher Education Council).
4. TÖMER (C1 or C2 level) or DİLMER proficiency certificate. (If it is not available at the time of registration, the relevant document must be submitted within 1 (one) year after the start of education). If the language proficiency certificates cannot be submitted during registration, the student is enrolled in the preparatory class for 1 (one) year. Students who have completed their undergraduate or graduate studies in Turkey will be exempted from the TÖMER certificate.
5. Notarized Turkish translation of the passport translated by a sworn translator. There must be a border entry stamp on the passport.
6. Criminal Record Certificate (They can apply to the consulate where they are located)
7. 6 biometric passport photographs taken within last six months (must be in ICAO standards)

INFORMATION ON RESIDENCE PERMITS;

- During the recruitment of international students, procedures will be carried out in accordance with the Cooperation Protocol on Residence Permit Applications of International Students between the Ministry of Interior and the Directorate of Migration Management and the Application Guide on Registration and Residence Permit Procedures of International Students.
- The legal entry and expatriate rights of International Students in Türkiye will be checked with the documents submitted in accordance with the Implementation Guide on Registration and Residence Procedures of International Students. If irregularities are detected with respect to their legal entry or expatriate rights in the country, the registration process will be postponed and Konya Provincial Directorate of Migration Management will be contacted.
- Students (to be announced later) who are entitled for final registration in our graduate programs must submit their final registration petition and documents declared in the link (https://www.selcuk.edu.tr/Birim/enstituler/saglik_bilimler_ens/1839/formlar-ve-belgeler/44864) to this Institute until **January 16, 2026**. Residence permit procedures will be carried out by the Institute's Student Affairs Department after the student submits the necessary documents.

DOCUMENTS TO BE SUBMITTED BY STUDENTS WHO ARE ELIGIBLE FOR FINAL ENROLLMENT;

- Residence permit registration/application form (originally signed by the student)
- Passport or passport substitute document (certified as original seen)
- Document showing student status
- 4 biometric photographs
- Valid health insurance (GHI or private health insurance covering the period of residence permit request)
- Document showing the residence address
 - If he/she is staying in his/her own home, a copy of the title deed (for extension applications, "certificate of residence and invoice" is sufficient)
 - Notarized copy of the lease agreement if residency is based on a lease agreement
 - If a residence in a hotel, etc. is the case then a document indicating such residency
 - If a residency in a student dormitory is the case then proof of residency in the dormitory
 - Notarized consent of the person staying with the student if the student is staying with a supporter (If the sponsor is married, notarized commitment of his/her spouse as well)
- Receipt of payment of the residence permit document fee
- For foreigners under 18 years of age; for those arriving with a visa exemption or with a visa for a different purpose; a document containing the information of the parent/guardian (birth certificate, family certificate, etc.) and the consent given by the parent/guardian/legal representative (for those arriving with a visa for the purpose (study visa); the consent and the document containing the information of the parent/guardian will not be attached).

GENERAL INFORMATION

- You cannot concurrently enroll in more than one program.
- Candidates who have a bachelor's or master's degree in fields other than the department to which they apply, and candidates who have received their bachelor's or master's degree from another higher education institution may be admitted to the "Scientific Preparatory Program".
- The applied Department has the right to conduct a written exam and/or an oral interview.
- Candidates who have dual citizenship in addition to their Turkish citizenship and graduated from any university in Turkey at an undergraduate level cannot apply as a foreign student.
- Candidates who are entitled to final registration will lose their registration rights if they do not register within the deadline.
- During the 2025-2026 Academic Year, the 'Current Service Cost' will be collected as 3 (Three) times of the service cost determined by the 'Presidential Decree on the Determination of Contribution Fees and Tuition Fees to be Received as Student Contribution to Current Service Costs in Higher Education Institutions' published in the Official Gazette. The annual fee will be paid at the beginning of the fall and autumn semesters, including the periods of scientific preparation and Turkish language education programs. In the following academic years, it will be updated every year as 3 (three) times the current service cost within the framework of the Presidential Decree published in the Official Gazette for the relevant year.
